



## BUDGET PAYMENT PLAN

### PAY FOR YOUR PROPANE ON OUR EASY BUDGET PLAN

Get on our budget payment plan where we estimate your total fuel bill on the basis of past gallon usage. The estimated gallons are multiplied by the price per gallon then divided into 11 equal monthly payments (plus taxes and fuel cost recovery fees.)

Budget customers receive a FIVE (.05) CENT PER GALLON DISCOUNT at the time of delivery (IF NOT CONTACTED IN).

#### **BUDGET PAYMENT PLAN- Terms and conditions**

1. You must have approved credit with Blue Flame Propane, Inc.
2. Current account balance must be paid in full before budget begins.
3. Budget payments are due the 10<sup>th</sup> of each month, beginning July 10<sup>th</sup> and ending May 10<sup>th</sup>. If we do not receive your payment by the last day of the month, you will be removed from the Budget plan. The balance owing when removed from the budget Plan will be due in full within in 30 days.
4. June is settlement month for the Budget Payment Plan. Unpaid balance will be due and payable by June 30<sup>th</sup>. Over payments at May 31<sup>st</sup> will be applied to your next heating season unless you notify your local office to request a refund. Customers in good standing will remain on the Budget Plan until the customer notifies Blue Flame Propane, Inc. in writing they want to be removed from the Budget Plan.
5. Monthly payments may be adjusted at the company's discretion if the price of product or consumption warrants a change. Should usage vary significantly from the prior year due to change in supplemental heat, remodeling, additions, etc., the consumers should contact their local branch office to review their budget payment.
6. Customers will be notified via letter in the new monthly payment calculation.
7. If you wish to take advantage of this plan, please sign and return the bottom portion of this letter to you local Blue Flame Propane, Inc. office. Budget customers are not guaranteed a price unless they have also signed a PRICE PROTECTION AGREEMENT.
